The National AOTS is an association of Men's Clubs in the United Church of Canada. The National AOTS achieves its outreach through the projects and activities of both local clubs and the National AOTS organization.

One of the principle aims of The National AOTS is:

To give encouragement and practical assistance to work among the youth of the church and community.

The National AOTS initiated the **Camp Improvement Project** in 2012 to support Canadian not-for-profit camps that offer youth camping programs as a large part of their mission. The project goal is to provide financial grants targeted to improving camp facilities and/or equipment. Support from The National AOTS, we hope, will assist camps in achieving their mission as it relates to youth camping.

Please read the granting guidelines and criteria carefully prior to completing the application.

- Grants will be awarded to a maximum value of \$2,000.
- Grants will be awarded for definite purposes and for projects covering a specific time.
- Grants will be awarded for camp facilities improvements including new construction, renovation, new equipment, upgrades to equipment or other projects that benefit youth in their camping experience.
- Applications must be supported by an AOTS Men's Club member (please write for assistance if needed).
- Applications will be considered for total or partial funding for the proposed improvement. For partial funding, the Camp must commit to securing the additional funds and completing the improvement.
- 2018 applications must be received by February 28, 2018.

To be eligible to receive a grant, a camp must

- Be a registered charitable organization as determined by the Canada Revenue Agency
- Be a Camp organization operating in Canada
- Offer youth camping programs as a large part of their mission
- Be in operation at least three years prior to application

The following activities are NOT eligible for Camp Improvement Project grants

- Annual fund drives, building campaigns, debt reduction, or endowment funds
- Core operating or administrative expenses
- Pilot or demonstration projects
- Projects already started or that will be completed before the grant approval

Application Procedure

1. Save this form to your computer with a unique file name in MS Word format such as your Camp Name.
2. Type or paste in the required information. Input boxes will expand to fit your needs.
3. Save the file.
4. Create an email to camp@aots.ca and attach your saved application.
5. Supply additional information that you think might help the Committee in their selection process. Electronic documents or links are preferred.
6. We may request a teleconference call.
7. We will acknowledge receipt of your application within 2 weeks and e-mail an update of the AOTS National Executive's decision by the end of March 2018
8. Application deadline is February 28, 2018. - CONTINUE REVIEW OF DOCUMENT AT THIS POINT -

Grant Process

1. The Camp Improvement Committee will evaluate all applications and recommend grant recipients to The National AOTS Executive.
2. The Executive will approve grant recipients based on the committee's recommendations and funds available. The decision of the Executive is final.
3. Applicants who don't receive a grant will be informed by email.
4. Approved recipients will be notified by email.
5. An agreement setting out terms and conditions of the grant may be required before funds are released.
6. Approved recipients of a grant must:
 - a. Provide documentation, if requested, to prove the grant funds were allocated to the project applied for.
 - b. Provide a digital photo of the project for use in AOTS publications.
 - c. Provide the AOTS with a follow up report in a timely fashion.
 - d. Provide a charitable donation receipt for the total grant received.
