BM-09-04-07 AM-09-04-16 **Report from the Think Tank Group** - at Church House on Wednesday of this week - Jim McKibbin

This group was composed of men representing the National AOTS and others representing Men's Work interests and groups from the Greater Toronto area, and Ontario. Organized by Lloyd Paul, Bill Love, Jim McKibbin, & George Bishop

Jim explained there was afternoon discussion groups formed to look the following: First of all the three pillars of AOTS, 1. **Fellowship**, 2. **Service & Outreach**, 3.**Spirituality**, and a fourth group the **Structure of Men's Ministry**, this was the group that Jim was part of. He outlined some of the conclusions the group came to.

Jim presented a Power Point Presentation on the suggested fundamentals and Values for a revised Men's Ministry Structure that were discussed by his groups on Wednesday.

Some of the highlights from the presentation are as follows:

Values: Independence, National perspective, some conflict between these two. Honouring tradition, Embracing change, motion and development, again some conflict between these two, Communication, Men for men, Servant leadership

Some of the to do's for AOTS: To look at the National AOTS structure, be more promotional in our approach, proactively promote gender based groups i.e. Men's Clubs in Theological Colleges, finally an emphasis on Youth work.

BM-09-04-08 **A look at the Environment** - Paul Cooper - No specific steps, Congregations through their Finance or Property Committee should look at Green technologies, and renewable resources

BM-09-04-09 **2011 Biennial Convention -** Central Region has been asked to help put on the convention, likely in conjunction with a Regional event

BM-09-04-10 **2013 Biennial Convention -** Newfoundland have indicated they would like consider hosting this convention

BM-09-04-11 **Looking a Restructuring of National Council -** presented by Ken Lane MOTION: *McKibbinl/Lane* We move or recommend that the Constitution Committee, or a special appointed Committee thoroughly review all phases of the structure of the National Council of AOTS, the Constitution and Bylaws, and present their recommendations and revisions to the next Annual meeting for approval, and that the approved revisions be circulated to the AOTS membership as per our present Constitution, prior to a vote for implementation at the next Biennial Convention.
